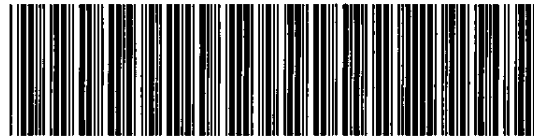

Pursuant to the provisions of Section 617.1006, Florida Statutes, the above named Florida corporation not for profit adopts the following amendment to its Articles of Incorporation.

FIRST: ARTICLE I of the Articles of Incorporation, as previously amended, is hereby amended to be as follows:

NAME


The name of this corporation shall be RINGLING COLLEGE LIBRARY ASSOCIATION, INC.


SECOND: The date of adoption of this amendment was May 14, 2007.
