AMENDMENT TO ARTICLES OF THE PURE CHURCH OF RIGHTEOUSNESS, INC.

ARTICLE X

All Amendments to the Articles of Incorporation may be proposed and adopted by submitting the same to the Board of Directors, and a majority adopt the same.

ARTICLE XII

The corporation must possess a seal which shall be in the possession of the Bishop, Assistant Bishop, or President. The design of the seal may be selected by the officers of the corporation, but said design cannot violate any of the laws of Florida, of the United States of America, and the said seal and design selected by the officers shall be the official seal of the Corporation.

ARTICLE XIV

The term of office shall be proposed and adopted by submitting the same to the Board of Directors, and a majority adopt the same.

ARTICLE VI

This corporation shall be contracted and managed by a Bishop, Overseer, and President. The election for the appointment of all officers to manage and contract all the affairs of this non-profit corporation, shall be held the third Saturday of February 1999, and the third Saturday of each February, for the years succeeding the year of 1999.
