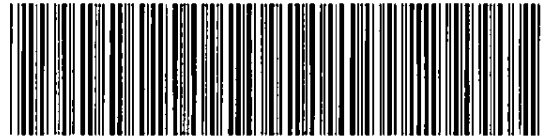

The undersigned subscribers, MOSE WILLIAMS, CLARENCE GARY, A. D. HAMPTON, and M. GARY, persons competent to contract for the purposes of forming a non-profit corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be THE PURE CHURCH OF RIGHTEOUSNESS, INC. Said corporation shall be a non-profit corporation.

ARTICLE II

The purpose of said non-profit corporation shall be a religious society and the object of said corporation shall be to preach and spread the Lord's word and help the poor and underprivileged people of the United States of America.

ARTICLE III

The qualifications of members and the manner of their admission shall be as follows: That all religious, Christian people may become a member of this non-profit corporation or religious society that a member who seeks admission is a Christian who believes in a supreme being and confesses to have religion.

ARTICLE IV

The terms of this non-profit corporation is to exist so long as the laws of the State of Florida and the United States of America will allow the same to exist.

ARTICLE V

The names and residences of the subscribers which are also the directors of said corporation are as follows: MOSE WILLIAMS

ARTICLE VI

This corporation shall be contracted and managed by a Bishop, Overseer, President and Senior Deacon.
