Name & Offices**

**Name**

Section 1. The name of the corporation shall be the Islamic Society of Central Florida, Inc. (ISCF).

**Principal Offices**

Section 2. The main office of the ISCF corporation shall be in Orange County, State of Florida.

Principle**

**Principle**

Section 1. The ISCF shall organize activities and provide opportunities for the spiritual training of its members in accordance to the teachings of the Quran and the teachings of Prophet Muhammad (p.b.u.h.).

**Article 3  
Purpose & Policies**

**Purpose**

Section 1. The ISCF is an independent organization. It is organized exclusively for religious, charitable, social, and educational purposes, including for such purposes, the making of contributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954, or the corresponding of any future U.S. Internal Revenue Law.

**Services**

Section 2. The ISCF shall provide religious, educational, and social services to all Muslims and provide channels of understanding and communication between Muslims and the general community.

**Policies**

Section 3. The ISCF's policies are based on the sources of Islam, namely, The Glorious Quran and the Sunnah (authentic traditions) of Prophet Muhammad (p.b.u.h.).


**Section 1.** The Board of Directors by two-third majority of its board members can from time to time amend any part of these articles except for Article One (1), Two (2), and Eight (8).
