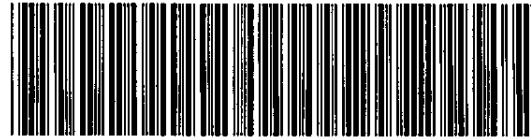

1. Article XIV (regarding Amendment) is hereby amended, to read as follows:


These Articles of Incorporation may be amended at any time and from time to time by resolution adopted by a majority of the Board of Directors and approved by a vote of two-thirds (2/3rds) of the members of this Association present, in person or by proxy, at any duly convened meeting of the members of the Association called at least in part to consider such amendment, or approved in writing by the members of this Association having not less than a majority of the total membership vote.

2. THE FOREGOING AMENDMENT was adopted by affirmative vote of at least 2/3's of the members present, in person or by proxy, at a duly noticed meeting of the Association called for this purpose on the 4<sup>th</sup> day of September, 2014, pursuant to Article XIV of the Articles of Incorporation, and the number of votes cast was sufficient for approval.
