We believe that in order to preserve the function and integrity of Joy Fellowship Ministries, Inc. as the local Body of Christ, and to provide a biblical role model to the members of Joy Fellowship Ministries and the community, it is imperative that all persons employed by Joy Fellowship Ministries in any capacity, or who serve as volunteers, agree to and abide by this Statement of Marriage, Gender, and Sexuality (Matthew 5:16; Philippians 2:14-16; 1 Thessalonians 5:22). We believe that God offers redemption and restoration to all who confess and forsake their sin, seeking His mercy and forgiveness through Jesus Christ (Acts 3:19-21; Romans 10:9-10; 1 Corinthians 6:9-11). We believe that every person must be afforded compassion, love, kindness, respect, and dignity (Mark 12:28-31; Luke 6:31). Hateful and harassing behavior or attitudes directed toward any individual are to be repudiated and are not in accord with Scripture nor the doctrines of Joy Fellowship Ministries.
