**RESTATED ARTICLES OF INCORPORATION
OF THE
LATVIAN ASSOCIATION OF ST. PETERSBURG, FL, INC.**

These Restated Articles of Incorporation are being submitted pursuant to Fla. Stat. 617.1007. All amendments contained in these Restated Articles of Incorporation were submitted to the members and directors who approved such amendments by sufficient votes cast for the amendment. No other approvals were required for such amendments. These Restated Articles of Incorporation consolidate all amendments through the date of adoption (which is listed in the certification below).

ARTICLE I -Name

The name of this corporation shall be the Latvian Association of St. Petersburg, FL, Inc.

ARTICLE II -Purpose

This not for profit corporation is organized for the purpose of promoting public appreciation and awareness of Latvian culture, uniting Latvian society in Florida, and promoting Latvian ethnic awareness. The corporation will organize activities and performances to promote Latvian traditions, language, and the arts.

This corporation is authorized to do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, associations, trusts, institutions, foundations, or governmental entities.

This corporation is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. The Corporation shall not distribute any gains, profits, or dividends to the directors or officers thereof, nor to any individual, except as reasonable compensation for services actually performed in carrying out the Corporation's purpose. The property, assets, profits, and net income of the Corporation are irrevocably dedicated to the Corporation's purpose.

ARTICLE III -Term

This Corporation shall have perpetual existence.

ARTICLE IV -Membership

The duties, rights, and qualifications for members shall be set forth in the Bylaws of this Corporation.

ARTICLE V -Board of Directors

The directors of the Corporation shall be elected in accordance with methods and qualifications specified in the bylaws of the Corporation. In no event, shall the number of directors be fewer than five.

ARTICLE VI -Bylaws

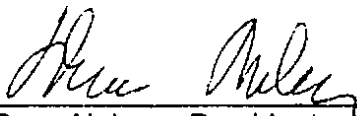

ARTICLE VII -Amendments to Articles of Incorporation

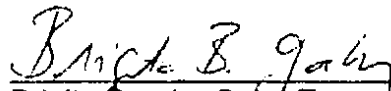
