## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

Latin Chamber of Commerce of the Tampa Bay Area, Inc. (the "Corporation"), a Florida nonprofit corporation, pursuant to Chapter 617, Florida Statutes, files the following amendment to the Articles of Incorporation, which amendment was duly adopted by the majority of the directors then in office entitled to vote on the amendment:
