As we discussed, enclosed is the Uniform Business Report for the referenced corporation together with a check in the amount of \$122.50 for the last two years.

It is my understanding that the prior UBRs for the corporation were being sent to 4230 S. MacDill Avenue, Tampa, Florida. The corporation vacated that location over 2.5 ago and, thus, did not receive the UBRs. The corporation's failure to file a UBR was certainly not intentional. The corporation is a not-for-profit organization and it would present a substantial financial burden on the organization to be required to pay a penalty. Accordingly, we respectfully request that any penalty for failure to file be waived.

Also enclosed for filing are the Articles of Amendment to the Articles of Incorporation that had been previously submitted and rejected because of the corporation's failure to file annual reports.

Please let me know if there is anything else that you require from us in order to reinstate the corporation and to carry out the name amendment.
