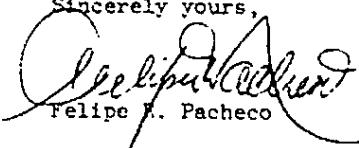

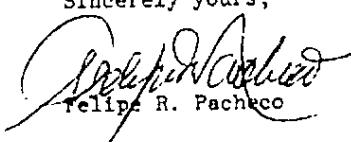

The undersigned, acting as subscribers of a corporation not for profit under the provisions of Section 617.013 of the Florida Statutes, adopt the following Articles of Incorporation for such corporation:

Article I. Name

The name of the corporation is: CHAMBER OF THE LATIN COMMERCE OF TAMPA, INC. (CAMARA DEL COMERCIO LATINO DE TAMPA, INC.).

Article II. Purposes

The purpose or purposes for which the corporation is organized are:

- a) the development, promotion and protection of the Latin commercial, financial, industrial and professional population of Tampa and its environment.
- b) the advancement of the civic interests of the community and especially of its population of Latin origin.
- c) the fostering of the development of Tampa and its environment in all fields of progress, such as education, cultural activities, transportation and communication.
- d) the cooperation with organizations of similar or identical purposes for the benefit of business in general.
- e) the engagement in all activities in relation to the objectives enumerated in these Articles or any amendment thereto, doing all and everything necessary and proper to the accomplishment of the goals of this corporation, and any other activities permitted under the laws of the United States of America and of the State of Florida.

Article III. Membership

The membership of this corporation shall consist of all persons hereinafter, named as subscribers, directors or officers and such other persons, associations, corporations, partnerships or estates as from time to time hereafter, may become members. The qualifications

of members shall be, besides what the by-laws will establish in relation to membership fees and such other matters necessary for reaching the purposes of the corporation, the following:

a) To be a natural person over eighteen (18) years of age, of good character and credit, and in some way connected with the purposes of this corporation.

b) To be an association, corporation, partnership or estate, in good standing, which in some way connected with the purposes of this corporation submits its application signed by a legal representative of such organization.

Any application for membership should be submitted in writing with the endorsement of two members in good standing and should be presented for the final approval of the Board of Directors of this corporation in the manner that the by-laws will establish.

These articles of incorporation may be amended at a special meeting of the membership called for that purpose, by a 3/4 vote.

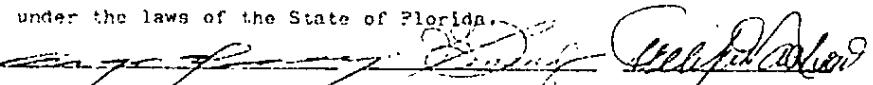
Amendments may also be made at a regular meeting of the membership upon notice given, as provided by the by-laws, or intention to submit such amendments.

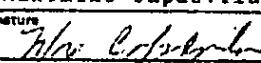
