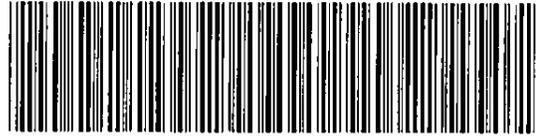

ARTICLES OF CONSOLIDATION

The EVANGEL TABERNACLE, ORLANDO, FLORIDA, a non-profit corporation under the laws of the State of Florida, did on the 19th day of July, 1975 and on the 24th day of August, 1975, hold Special Business Meetings of the members of said corporation at which meetings a quorum was present. The purpose of said meetings was to present a plan of consolidation with EAST ORANGE ASSEMBLY OF GOD, INC., a non-profit corporation under the laws of the State of Florida.

The EAST ORANGE ASSEMBLY OF GOD, INC., a non-profit corporation under the laws of the State of Florida, did on the 13th day of July, 1975 and on the 24th day of August, 1975, hold Special Business Meetings of the members of said corporation at which meetings a quorum was present. The purpose of said meetings was to present a plan of consolidation with the EVANGEL TABERNACLE, ORLANDO, FLORIDA, a non-profit corporation under the laws of the State of Florida.

The plan of consolidation set forth hereinafter received approval by in excess of a two-thirds vote of the members present at said meetings.

SECTION ONE

The plan of consolidation approved the following:

- A) The combining of all assets and liabilities of the two non-profit corporations into the new corporation;
- B) The placing on the market for sale of the real property of the EVANGEL TABERNACLE, ORLANDO, FLORIDA;
- C) The initial meetings of the combined congregations and members of the two non-profit corporations to be held at EAST ORANGE ASSEMBLY OF GOD, INC.;
- D) On sale of the real property of the EVANGEL TABERNACLE,

ORLANDO, FLORIDA, the consolidated corporation would begin to build on property now owned by EAST ORANGE ASSEMBLY OF GOD, INC. and, if necessary, move to said property while new facilities are under construction;

E) Brother David Arnold would be the Pastor of the consolidated Churches, probably assisted for a short time by Brother Norice Gallop, at which time Brother Gallop's resignation would become effective;

F) The name of the new consolidated non-profit corporation would become FAITH ASSEMBLY OF GOD OF ORLANDO, INC.;

G) The membership of each non-profit corporation shall be officially merged and combined effective August 24, 1975;

H) The active, inactive, and junior memberships of the two non-profit corporations be herewith established as active, inactive and junior membership of the newly formed FAITH ASSEMBLY OF GOD OF ORLANDO, INC.;

I) The members of both Boards of Trustees of the two non-profit corporations shall combine as the committee needed to oversee the contracting of all legal work necessary in the effecting of this consolidation.

#### SECTION TWO

1. The name of the new consolidated non-profit corporation shall be FAITH ASSEMBLY OF GOD OF ORLANDO, INC.

2. The purpose of the new corporation is as follows:

A) To establish and maintain a place for the worship of Almighty God, our Heavenly Father; to provide for Christian fellowship for those of like precious faith, where the Holy Ghost may be honored according to our distinctive testimony; to assume our share of responsibility and the privilege of propagating the gospel of Jesus Christ by all available means, both at home and abroad.

B) To perpetuate, promulgate, and support the doctrines

of the General Council of the Assemblies of God, and it, and all its property, both real and personal, shall be subject to the laws, usages and ministerial appointments of the General Council of the Assemblies of God, Springfield, Missouri, and the Peninsular Florida District Council, Lakeland, Florida, as are now or shall be from time to time established, made, and declared by the lawful authority of the said councils.

C) The corporation shall have the power to acquire and hold title in fee simple, in trust, or otherwise, to both real and personal property, and to improve, encumber, sell, convey and dispose of all such property in conformity with the By-Laws of said corporation, and each and every power and right granted to Corporations Not for Profit under the Laws of the State of Florida.

3. Qualification of the members and the manner of their admission to the new corporation shall be as follows:

The members of the corporation shall be all members in good standing at any give time of the FAITH ASSEMBLY OF GOD OF ORLANDO, INC.

4. This corporation shall exist perpetually or until dissolved by due process of law. Should this corporation cease to exist as a legal entity and its charter be terminated, title to all its property automatically shall become vested in the Peninsular Florida District Council of the Assemblies of God, Inc., of Lakeland, Florida in the same manner as it holds title to any other property.

The President and Trustees shall constitute and be the official Board of Directors. They shall be elected from time to time in accordance with the By-Laws.

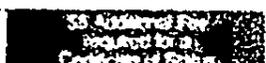
