Pursuant to the provisions of Florida Statutes §617.1402 and §617.1403 and authorized by majority vote of the Board of Directors the following Articles of Dissolution are hereby authorized by the Corporation as follows:

Article I

The name of the corporation is ASAMBLEA MISIONERA ELIM, INC.

Article II

The members of the Corporation are not entitled to vote on dissolution. A resolution was passed and adopted by the Board of Directors with votes sufficient for approval.

Article III

The date the dissolution was authorized by resolution of its Board of Directors was the 11th day of June, 1997.

Article III

That the debts of the corporation which remain unpaid shall be paid by a successor corporation to be formed simultaneous to dissolution. The directors, are all authorized to transfer the remaining assets of the corporation to the successor corporation.

Said directors are further authorized to engage legal counsel and an accountant to assist in the dissolution and transfer of assets and liabilities professional and to pay such fees reasonable and necessary to implement the dissolution and transfer of assets.

Further, the Directors are authorized to close and open such bank accounts and to do all things necessary to carry out the dissolution.

Article IV

No assets, funds, property, receivable, donations or any other tangible or intangible things of value shall be sold or distributed or transferred to any individual or entity who or which is not a charitable institution or religious organization defined by IRS code 501(c)3.

Article V

That the corporation is dissolved effective upon the filing of the articles with the Secretary of State.
