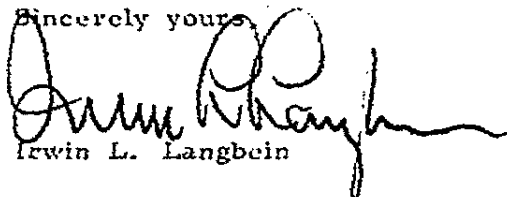

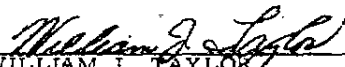

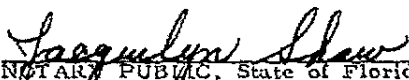

WILLIAM J. TAYLOR, being duly sworn, says on his oath:

I am president of PALM BEACH COUNTY ASSOCIATION FOR RETARDED CITIZENS, INC., formerly known as PALM BEACH COUNTY ASSOCIATION FOR RETARDED CHILDREN, INC. My term of office as president of that Association commenced May 19 1975. I have no first-hand information of the activity of that Association earlier than March 1972, the time when I first became a member of the Association. In response to a form inquiry from the office of the secretary of state of Florida dated December 15 1975 I have personally inspected the minute books of the Association dating back to its organization in 1958. On or about November 20 1975 I executed as president of the Association a certificate for reincorporation of the Association which accompanied my resident agent certificate, both filed with the secretary of state shortly thereafter. To that reincorporation certificate was appended a copy, certified by the Clerk of the Circuit Court of Palm Beach County, of the charter of the Association. That clerk's certificate also recites that there have been no revocations or dissolutions of that charter recorded as of October 24 1975, and is true and correct to the best of my knowledge and belief. To the best of my knowledge and belief there have been in fact no charter documents whether recorded or unrecorded other than as recited in that clerk's certificate.

CHARTER

1

PALM BEACH COUNTY ASSOCIATION FOR RETARDED CHILDREN, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation, not for profit, under the laws of the State of Florida (Chapter 687, Florida Statutes), and hereby adopt and subscribe to the following as the charter thereof:

ARTICLE I

The name of the corporation shall be PALM BEACH COUNTY ASSOCIATION FOR RETARDED CHILDREN, INC., and the place where it is to be located shall be the City of West Palm Beach, Palm Beach County, Florida.

ARTICLE II

The general nature of the object of the corporation shall be:

- (1) To provide the general welfare, whether at home, in the community, in public, private or religious schools and institutions, or elsewhere, of mentally retarded persons in Palm Beach County, Florida, the State of Florida, the United States of America and other countries.
- (2) To conduct all and foster integrated programs for the development of mentally retarded persons.
- (3) To advise and aid parents of mentally retarded or deficient persons in the solution of their problems, and to coordinate the efforts and activities of such parents of retarded children.
- (4) To develop a better public understanding of the problems of mental deficiency and retardation.
- (5) To associate with public, private and religious organizations and agencies in the gathering and dissemination of information regarding mentally retarded and mentally deficient persons, their care, treatment and education, and to solicit, receive and disburse funds in connection therewith.

ARTICLE VI

Section 1. The affairs of the corporation shall be managed by a president, vice-president, secretary, treasurer, and a Board of Directors which shall not be less than three but may be any number in excess thereof, determined by a vote of the members of the corporation and as the By-Laws may direct.

Section 2. Vacancies in office and upon the Board of Directors shall be filled by a majority vote of those members of the corporation participating in elections to be held on the first Monday in April of each year.

Section 3. The president, vice-president, secretary and treasurer shall be elected for terms of one year each and shall hold office until their successors shall have been elected.

Section 4. The president, vice-president, secretary and treasurer shall, ipso facto, be members of the Board of Directors. One member of the first board of directors shall be elected for a term of one year and, thereafter, each immediate past president of the corporation shall, ipso facto, become the successor of each member of said board. On the first board of directors one-half plus one shall be elected for terms of one year each and the remainder for terms of two years each. Thereafter the directors to be elected shall be elected for terms of two years each or until their successors shall have been elected.

Section 5. In the event any vacancy shall hereafter occur on the Board of Directors through the removal, death or disability, making it impossible for a director to serve as such, the members of the organization shall elect a successor to fill the vacancy so created for the remainder of the unexpired term. Such election shall be held only after such notice, if any, as the By-Laws may require.

Section 6. The members of the organization shall have full power and authority to determine the disability of any of the officers or members of the Board of Directors, and to remove from office any officer or director, and any such action taken by the organization upon affirmative vote of a majority of the members, shall be conclusive.

Section 12. The Board of Directors shall have full power and authority to appoint such agents and employees as may be prescribed by the By-Laws, and as it may deem necessary for the successful management for the affairs of the corporation.

ARTICLE VII

ARTICLE VIII

The By-Laws of the corporation shall be made, altered or rescinded when deemed expedient, and when authorized by the affirmative vote of the members of the corporation, without prior notice, at any annual meeting of the corporation, or at a special meeting called for that purpose, of which special meeting notice shall be given in the manner provided for in the By-Laws. Twenty (20) members in good standing shall constitute a quorum for the purpose of conducting any regular or special meeting.

ARTICLE IX

The highest amount of indebtedness or liability to which the corporation may at any time subject itself shall never be greater than two-thirds of the value of the property of the corporation, or if the value of the property of said corporation shall exceed \$500,000.00, the highest amount of indebtedness or liability in which the corporation may at any time subject itself shall not exceed \$500,000.00.

ARTICLE X

The amount and value of the real estate which the corporation may hold, subject to the approval of the Circuit Judge, shall be One Million Dollars (\$1,000,000.00).

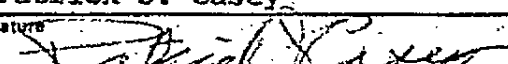

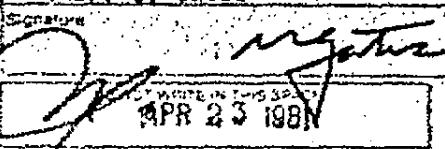

ARTICLE I

Article VI of the Articles of Incorporation of the Palm Beach County Association for Retarded Citizens, Inc. shall be amended to read as follows:

Section 1. The affairs of the corporation shall be managed by a President, President-Elect, Immediate Past President, Vice President, Secretary, Treasurer, and Board of Directors consisting of the aforementioned officers and at least three and not more than 31 members of the corporation, determined by vote of the members of the corporation, cast as the Bylaws may direct.

Section 2. Upon the expiration of a term of office on the Board of Directors, the members of the association shall, at the annual meeting of the membership, elect an individual to fill the vacant directorship created by such expiration. In the event of a vacancy occurring in the Board of Directors prior to the expiration of a term of office, the remaining directors may fill such vacancy for the unexpired term. In the event of a vacancy in the office of the President, the President-Elect shall become President automatically. In the event of a vacancy in any of the other offices enumerated in Section 1 hereof, such vacancy may be filled by the Board of Directors at any regular or special meeting thereof.

Section 3. The officers of the corporation mentioned in Section 1 of this Article shall be elected for terms of one year each at the annual meeting of the membership of the corporation and shall hold office until their successors are elected and have qualified. The annual meeting of the members of the corporation shall be held some time during December or January of each year in Palm Beach County, Florida, the precise place and time to be designated by the Secretary under notice sent in accordance with the Bylaws.

Section 4. Directors of the corporation shall serve for three-year terms, so staggered as to make approximately one-third of the Board of Directors electable at each annual meeting of the members of the association. The number of directors for the ensuing year shall be determined by vote of the membership at the annual meeting, provided, however, that the directors may increase the number of directors up to a maximum of 31, such additional directors to serve only until the next ensuing annual meeting of the membership, in accordance with the Bylaws.

Section 5. In the event of a vacancy occurring in the Board of Directors prior to the expiration of a term of office, the remaining directors may fill such vacancy for the unexpired term, as provided in the Bylaws.

Section 6. Any director may be removed from office at any time with reasonable cause, by the affirmative vote of a majority of the members in good standing of the corporation then entitled to vote at an election of directors. Any officer of the corporation may be removed with reasonable cause at any time by the affirmative vote of a majority of the Board of Directors at any duly called regular or special meeting of the Board of Directors.

Section 7. All powers of the corporation shall be vested in the Board of Directors. It shall be the responsibility of the Board of Directors to establish and control the policies, business and goals (both short and long term) of the corporation, in accordance with the purposes for which it is organized and in accordance with the Bylaws of the corporation. The Board of Directors shall undertake such specific duties as may be provided by the Bylaws of the corporation and the Board of Directors may establish committees and designate committees and individuals to perform such duties as it may delegate to such committees and individuals.

ARTICLE II

Article VIII of the Articles of Incorporation of the Palm Beach County Association for Retarded Citizens, Inc. shall be amended to read as follows:

The Articles of Incorporation and Bylaws of the association may be amended, altered or rescinded, in whole or in part, by the affirmative vote of a majority of the members of the corporation represented either in person or by proxy at any annual meeting of the members, or at a special meeting of the members when such proposed action has been incorporated in the notice of the meeting or referred to in a waiver of notice duly signed by all members of the corporation entitled to vote at such meeting; provided, however, that such amendment, alteration or rescission is in accord with the purposes of the corporation as set forth in the Articles of Incorporation. Any proposed Bylaw change or change in the Articles of Incorporation shall be set out verbatim in the notice of the meeting, but it may be amended at the meeting, within the scope of its general subject matter, without further advance notice.

ARTICLE III

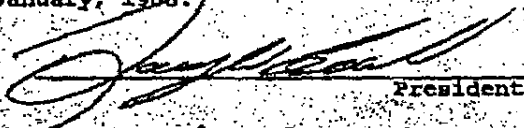

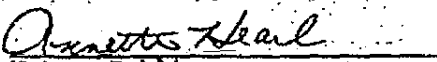
