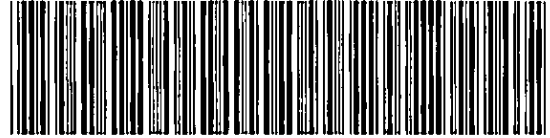



OF THE ARTICLES OF INCORPORATION OF WATER GLADES 200
CONDOMINIUM ASSOCIATION, INC.**

ARTICLE VII

Board of Administrators

7.1 The number of persons constituting the first board of administrators shall be three (3) and the names and addresses of the persons who are to serve as administrators until the first election thereof are as follows:

7.2 Thereafter the affairs of the Association shall be managed by a board consisting of ~~nine (9)~~ seven (7) members. All Administrators must be Unit Owners.

7.3 All of the duties and powers of the Association shall be exercised exclusively by the Board of Administrators, their agents, or employees, subject to approval by Unit Owners only when specifically required by the Declaration of Condominium, these Articles of Incorporation and the By-Laws. Except as otherwise provided in the By-Laws, Each Administrator shall serve for a staggered ~~three~~ two (2) year term unless he shall sooner resign, be removed, does not qualify to serve on the board under these Articles, the Bylaws or applicable law, or die.
