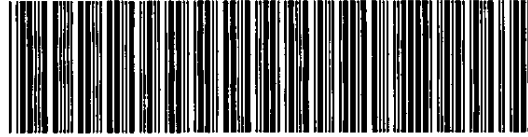


Minutes June 18,2015
