CERTIFICATE OF AMENDMENT TO THE **ARTICLES OF INCORPORATION** OF CONQUISTADOR HOMEOWNERS' ASSOCIATION, INC.

Every Director, every officer and every committee or sub-committee member of the Conquistador Homeowners' Association, Inc., shall be indemnified by the Conquistador Homeowners' Association, Inc., against all expenses and liabilities, including but not limited to attorneys' fees and costs, reasonably incurred by or imposed upon him in connection with any proceeding or settlement of any proceeding to which he may be a party or in which he may become involved by reason of his being or having been a director, officer, committee or sub-committee member of the Conquistador Homeowners' Association, Inc., whether or not he is a director, officer, committee or sub-committee member of said Association at the time such expenses are incurred, except when the director, officer, committee or sub-committee member at the time of such expenses are incurred is adjudicated guilty of willful misfeasance or malfeasance in the performance of his duties. The Conquistador Homeowners' Association, Inc., shall further hold harmless every director, every officer and every committee or subcommittee member of said Association for any negligent act, error and omission or breach of duty while acting in the capacity as a director, officer, committee or subcommittee member of said Association, except when the director, officer, committee or sub-committee member is adjudicated guilty of willful, misfeasance or malfeasance in the performance of his duties. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights and remedies to which such director, officer. committee or sub-committee member may be entitled.
