

## PLAN OF DISTRIBUTION

- A. Liabilities And Obligations of First Alliance Church Of Pensacola Florida, Incorporated: All liabilities and obligations of this corporation have been satisfied, and there are no known outstanding liabilities and obligations, whether liquidated or unliquidated, contingent or unconditional, presently due or coming due in the future.
- B. Distribution Of Assets: Pursuant to Articles II and IX of the Amended Articles of Re-Incorporation, which provide that, upon dissolution of the corporation, all assets shall be transferred to the district of the Christian And Missionary Alliance denomination of which the corporation is a member, and whereas the corporation is a member of the Southern District Of The Christian And Missionary Alliance, Inc., an Alabama not-for-profit corporation, all assets of the corporation shall be distributed to the Southern District Of The Christian And Missionary Alliance, Inc., an Alabama not-for-profit corporation. These assets include, but are not limited to the following:

Real Property:       The Westerly 48 feet of Lot 1, Block E, and Lots 39 and 40, Block S, Home Orchards Subdivision, a subdivision of a portion of Section 14, Township 2 South, Range 30 West, Escambia County, Florida, according to the plat thereof as recorded in Deed Book 87, Page 524, less and except the road right of way as described in Deed Book 497, Page 88, all of the Public Records of Escambia County, Florida, having a street address of 4918 Mobile Highway, Pensacola, Florida 32506.

Other Property:       All other property, whether real or personal, belonging to First Alliance Church Of Pensacola Florida, Incorporated, including but not limited to any and all bank accounts, notes receivable, furniture, books and hymnals, and equipment.
