Amendment: Article X, Section 4, Articles of Incorporation

ARTICLE X - VOTING

(Section 1 through Section 3 Remain Unchanged)

Section 4. At all elections of trustees, each certificate of membership shall be entitled to as many votes, as the number of trustees to be elected. All-of-the-votes-of-a certificate of membership may be east for a single-trustee or may be distributed among the number of trustees to be voted for, or any two or more of them, if appropriate, as-the-person-voting-the-certificate of-membership may see-fit. This section providing-for-cumulative-voting-shall-be-applicable-only where the number of trustees to be-elected-is-more than one.
