



AMENDMENT TO THE AND THE ARTICLES AND BYLAWS OF LIGHTHOUSE POINT ASSOCIATION, INC.

Note: Words stricken are deletions; Words underlined are additions.

Article IX, Section 1 of the Articles of Incorporation Shall be Amended as Follows:

Section I. Amendment to these Articles of Incorporation shall be proposed by a resolution adopted by two thirds—(2/3)a majority vote of the Board of Trustees. The resolutionamendment shall then be presented to the membership of the Association. A proposed amendment must receive approval of a majority of the voting interests of the Association that are actually present and voting, in person or by proxy, at a meeting of the members at which a quorum is present and for which proper notice has been given. A two-thirds—(2/3) vote of the certificates—of—membership cast—at a duly called meeting shall be necessary to amend the Articles of-Incorporation:
