



Additions to the existing provisions of the Articles are indicated by <u>double-underlining</u> and deletions to the existing provisions of the Articles are indicated by <u>strikeout</u>.
- II. Article VI, Section 1 of the Amended and Restated Articles of Incorporation of Spinnaker Cove Condominium Association, Inc. is amended to read as follows:

Section 1. The affairs and business of this the Association shall be managed and conducted by a Board of Directors consisting of not more than seven (7) nor less than five (5) persons, who are unit owners.
