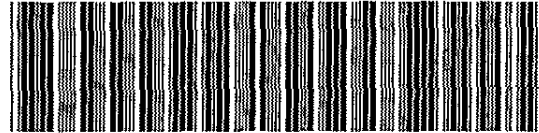

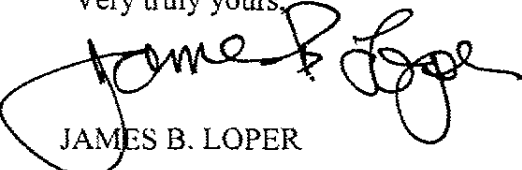

FIRST: Article I is amended as follows:

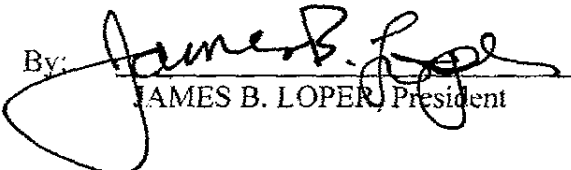
"The name of this corporation shall be CORNERSTONE FAMILY MINISTRIES, INC. effective October 1, 2006."
