Article X, Articles of Incorporation

ARTICLE X Amendments

Amendments to these Articles of Incorporation shall be prepared and adopted in the following manner:

(Sections 1 Unchanged)

- 2. A resolution approving a proposed amendment may be proposed by either the Board of Directors or by any one or more members of the Association. Directors and members not present in person, or by proxy, at the meetings considering the amendment may express their approval in writing, providing such approval is delivered to the Secretary of the Association prior to the meeting. Except as elsewhere provided.
- (in person or by proxy) and voting at a duly noticed meeting of the Association at which a quorum is present, or by the written agreement of 75% of the entire voting interests entire membership of the Board of Directors, and by not less than 75% of the votes of the entire membership of the Association; or
- (b) By not less than 80% of the votes of the entire membership of the Association.

Article VIII, Articles of Incorporation

ARTICLE VIII By-Laws

The first By-Laws of the Association shall be adopted by the Board of Directors named herein, and may be altered, amended or rescinded in the manner provided by the By-laws by:

- (a) Not less than 75% of the entire membership of the Board of Directors and by not less than 75% of the votes of the entire membership of the Association; or
 - (b) By not less than 80% of the votes of the entire-membership of the Association.
