



(Additions shown by underlining; deletions shown by lined-through words)

- 1. Amendment to Article XI of the Articles of Incorporation to provide as follows:
  - "11.2 (a) Such approvals must be by not less than two thirds of the entire membership a majority of the Board of Directors and by not less than fifty one (51%) percent of the votes of the entire members of the Association a majority of the owners present in person or by proxy at a meeting at which a quorum has been established; or
  - (b) By not less than two-thirds of the votes of the entire membership of the Association.
