
ARTICLES OF AMENDMENT

GLEN BAPTIST CHURCH, INC.


The Articles of Incorporation of this corporation are hereby amended such that Article I is amended to read as follows:



4. The undersigned are all of the Trustees of this non-profit corporation.



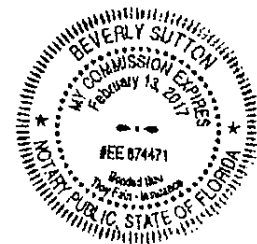


