The detail page presented on a search by name for the Ormond Beach Historical Society provides the incorrect FEIN for this organization. The data presented is 511993988. The correct FEIN as provided by their IRS determination letter is 51-0199398 (I have attached a PDF scan of this letter to this e-mail).

A search by FEIN, using the correct number, fails to find the organization, and indicates that there is no record using this correct FEIN in your database.

I suspect that this is the most difficult data to correct, but having the correct number in your database would be a great help for those of us who need to find this organizations data in your system.
