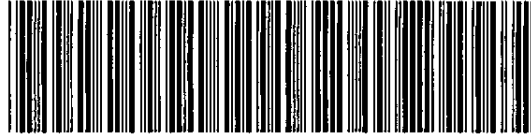

ARTICLE 2 PURPOSE AND STATEMENTS OF FAITH AND PRACTICE

2. Human Sexuality - The Bible teaches that legitimate sexual relations are excercised solely within marriage. Hence, this Church opposes all forms of sexual immorality, including adultery, homosexuality, and pornography.

Section C: Ordinances

This Church acknowledges the two Biblical ordinances of baptism by immersion, and the Lord's Supper.

Section D: Bylaws and Scripture

These bylaws and any amendments made hereto shall be the governing documents of this Church but they should always be interpreted and applied in conformity with the Bible.

Section E: Affirmation

Every pastor, staff member, and church member by virtue of their membership affirm their agreement with this Article 2 and agree to conduct themselves in a manner with which it is consistent.


