Pursuant to the provisions of Section 617.100.6 Florida Statutes, this corporation, GRACE BIBLE CHURCH OF NAPLES, INC., adopts the following articles of amendment to its articles of incorporation:

FIRST: *Amendments adopted:*

Article I is hereby amended in full to read as follows:

The name of the corporation shall be: Center Point Community Church of Naples, Inc., whose address is 6590 Golden Gate Parkway, Naples Florida 34105. For convenience, the corporation shall be referred to in this instrument as the Corporation.

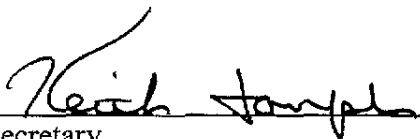
SECOND: *The date of the amendment's adoption:*
