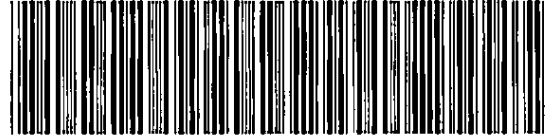

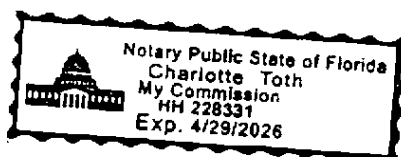

**ARTICLE OF AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF THE PINNACLE APARTMENTS, INC., A CONDOMINIUM**

Adopted amendment to ARTICLE I of the Articles of Incorporation of The Pinnacle Apartments, Inc., a Condominium, to read as follows:

**ARTICLE I**
