## AMENDED AND COMPLETELY RESTATED ARTICLES OF INCORPORATION

#### **OF**

## INDIAN RIVER COUNTY LIBRARY ASSOCIATION, INC.

WHEREAS the Articles of Incorporation for Indian River County Library Association, Inc. were filed on July 20, 1976; and

WHEREAS the members of the corporation wish to amend and completely restate the Articles of Incorporation; and

WHEREAS the members have approved such amendment and restatement pursuant to a vote in compliance with the terms and conditions of the Articles of Incorporation;

**NOW THEREFORE** the members of the corporation and the board of directors wish to adopt the following Articles of Organization in their entirety.

The undersigned, for the purposes of forming a corporation under Chapter 617 of the Florida Statutes, the Florida Not-for-Profit Corporation Act, hereby certifies:

## ARTICLE I

#### **NAME**

The name of the Corporation is **FRIENDS OF INDIAN RIVER COUNTY LIBRARY**, **INC.** 

### ARTICLE II

#### PRINCIPAL OFICE

The place of business of this Corporation shall be:

## ARTICLE III

### **EXEMPT STATUS**

This Corporation has not been formed for pecuniary profit or financial gain, and no part of the assets, income or profit of the Corporation is distributable to, or inures to the benefit of, its directors or officers except to the extent permitted under the Not-for-Profit Corporation Law. This Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

## **ARTICLE IV**

## **MEMBERSHIP**

Membership in this Corporation shall be in accordance with and governed by the Bylaws of the Corporation.

## ARTICLE V

#### **PURPOSES**

The general nature and purpose of the Corporation shall be solely and exclusively for the advancement of education, scientific and literary purposes, including the acquisition, establishing, maintenance and promotion of the use of public libraries in Indian River County, Florida; and the collection and care of materials and equipment relating to the above purpose. This corporation shall have such corporate powers as are granted in Chapter 617 of the Florida Statutes, and all amendments subsequent thereto. The foregoing shall be construed as both purposes and powers and the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this Corporation. For such purposes the Corporation shall have the power to buy, own, sell, lease, pledge and encumber real estate and personal property, and to accept gifts from any persons, firms or corporations of materials, money, securities, land or building to be used in the promotion and maintenance of libraries in Indian River County, Florida.

## **ARTICLE VI**

## **BOARD OF DIRECTORS**

The Board of Directors of this Corporation shall be elected and appointed as stated in the Bylaws. The name and street address of each director is:

#### ARTICLE VII

## DISTRIBUTION UPON DISSOLUTION

In the event of dissolution, all of the remaining assets and property of the Corporation shall, after necessary expenses thereof, be distributed to such organizations as shall qualify under Section 50l (c)(3) of the Internal Revenue Code of 1986, as amended, as determined by a majority of the Board of Directors.

## ARTICLE VIII

#### INCOME AND DISTRIBUTION

No part of the income of the Corporation shall inure to the benefit of any member, director, officer of the Corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes), and no member, officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.

## **ARTICLE IX**

## PROHIBITED ACTIVITIES

No part of the activities of the Corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

#### **ARTICLE X**

## REGISTERED AGENT

The registered office of this Corporation shall be located at 979 Beachland Blvd., Vero Beach, Florida 32963, and the registered agent of this Corporation at such office shall be Todd W. Fennell. This Corporation shall have the right to change such registered office and such registered agent from time to time, as provided by law.

#### ARTICLE XI

#### AMENDMENT TO ARTICLES OF INCORPORATION

This Corporation reserves the right to amend, alter, change or repeal any provisions contained in this Articles of Incorporation in the manner now or hereafter prescribed by statute, and all rights conferred upon the Board of Directors herein are subject to this reservation.
