

# THE KIWANIS CLUB OF ORLANDO FOUNDATION, INC. A FLORIDA CORPORATION NOT FOR PROFIT

The Board of Directors of THE KIWANIS CLUB OF ORLANDO FOUNDATION, INC., after ratification of the majority vote of those present at a special meeting of the membership called for the purpose of amending the Articles of Incorporation duly held on December 16, 2005, at which a quorum was present, hereby adopts the following amendments to the Articles of Incorporation of THE KIWANIS CLUB OF ORLANDO FOUNDATION, INC.:

1. ARTICLE VI is hereby amended to state as follows:

#### **ARTICLE VI - MEMBERSHIP**

Membership in this Foundation shall be as provided in the By-Laws of this Foundation.

2. ARTICLE VIII (A) is hereby amended to state as follows:

#### **ARTICLE VIII - OFFICERS**

- (A) The Board of Directors shall elect from its membership a President, one or more Vice-Presidents, a Secretary and a Treasurer. Any person may hold two or more offices except that the President may not also be the Secretary. No person holding two or more offices shall sign any instrument in the capacity of more than one office.
  - 3. ARTICLE IX (A) is hereby amended to state as follows:

#### **ARTICLE IX - BOARD OF DIRECTORS**

- (A) The members of the Board of Directors and the method of the election of Directors shall be as provided in the By-Laws of this Foundation.
  - 4. ARTICLE X (B) is hereby amended to state as follows:

### **ARTICLE X - BY-LAWS**

- (B) The By-Laws may be amended, altered, or rescinded by a majority vote of the members present at any regular meeting or at any special meeting called for that purpose, at which a quorum is present.
  - 5. ARTICLE XIII (A) is hereby amended to state as follows:

#### ARTICLE XIII - MEETINGS

(A) There shall be an annual meeting of the members of the Foundation, to be held by October 31 of each year at a time and place to be determined by the Board of Directors. Notice of such meeting shall be given to the members in such manner as the Board of Directors shall determine.

All of the remaining provisions of the Articles of Incorporation of THE KIWANIS CLUB OF ORLANDO FOUNDATION, INC. are hereby reaffirmed.

The above amendments were adopted by the members on December 16, 2005, and the number of votes cast for the amendments was sufficient for approval.
