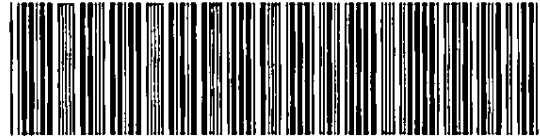

Article 3 of the Articles of Incorporation is amended to read:


Article 3

The powers of PRM Corp. shall include and be governed by the following provisions:

- 3.1 PRM Corp. shall have all of the common law and statutory powers as set forth in Florida statute 617 of the Corporation not for profit, not in conflict with the terms of these articles and Chapter 720 *et seq.*, and any subsequent amendments thereto, not in conflict with the terms of these articles.
- 3.2 PRM Corp. shall have all of the powers and duties permitted under the statutes of the State Of Florida including but not limited to the following:
 - (a) To make and to collect assessments and dues of members to defray the costs, expenses, and activities of PRM Corp., to place liens against any parcel for delinquent and unpaid assessments or charges and to bring suit for foreclosure of such liens or otherwise enforce the collection of such assessments and charges for the purposes of obtaining revenue to carry out the purposes and objectives of PRM Corp.
 - (b) To use the proceeds of assessments in the exercise of its powers and duties.
 - (c) To enforce by negotiation and/or legal means the purposes of PRM Corp.
 - (d) To contract for and delegate all powers and duties of PRM Corp as may be desired to improve the attainment of PRM Corp's aims.
 - (e) To employ personnel to perform the services required for proper operation of PRM Corp.
- 3.3 All funds acquired by PRM Corp. shall be utilized in accordance with the declared purposes and intentions of PRM Corp.
- 3.4 The powers of PRM Corp. shall be subject to and exercised in accordance with the provisions of these articles.

- There are no members or members entitled to vote on the amendment(s). The amendment(s) was/were adopted by the board of directors.
