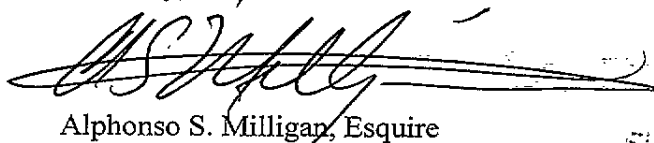

AMENDMENTS TO ARTICLES OF INCORPORATION

OF

**FREEDOM LEARNING CENTER, INC.**

The following amendments were adopted on the 21 day of June 2000 by a majority vote of the Board of Directors, member approval is not required.

Freedom Learning Center, Inc. is organized under the Non-Profit Corporation Law of the State of Florida.

**ARTICLE IV - GENERAL PURPOSES**

Said corporation is organized exclusively for religious, charitable and educational purposes to aid in the relief of the poor, the distressed, or the underprivileged, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The programs will include, but not limited to, real property acquisition, job creation, affordable housing, employability skills training and literacy.
