

Exhibit "1"

PROPERTY OWNERS' ASSOCIATION, INC.

- 1. Article IV.2 of the Articles of Incorporation shall be amended to read as follows:
 - The interest of any member in any lot or parcel of Property described "2. in Exhibit "A" attached hereto or in this Corporation cannot be conveyed, assigned, mortgaged, hypothecated or transferred in any manner except as an appurtenance to the said part of the Property owned by them. No person shall be a member of the Corporation after he ceases to be the owner of record of a lot or parcel of property described in Exhibit "A" attached hereto. The directors of the Corporation may, after affording the member an opportunity to be heard, suspend any person from membership in the Corporation during any period of time when there exists a lien or violation of any of the said Covenants and Restrictions (including, but not limited to; the failure to make any payment to the Corporation when due and payable or failure to satisfy a lien-placed on a lot or parcel by the Corporation under the terms hereof) with respect to the portion of the Property he owns."
- 2. Article IX of the Articles of Incorporation shall be amended to read as follows:

"ARTICLE IX

By-Laws

The By-Laws of the Corporation shall be adopted by the Board of Directors. Amendment, alteration, or rescission of said By-Laws shall be accomplished at a duly constituted membership meeting held for that purpose, provided; however, that no amendment shall take effect unless approved by members representing at least three-fourths of the total votes of the members of the Corporation. as provided for in the By-Laws, and shall be effective upon recordation in the public records of Palm Beach County, Florida."

3. A new Article XII shall be added to the Articles of Incorporation and shall read as follows:

"ARTICLE XII

Amendment to Articles of Incorporation

These Articles may be amended at a duly constituted membership meeting for the purpose, provided, however, that no amendment shall take effect

unless approved by the members representing at least two-thirds of the total vote of the members of the Corporation. The amendment shall be filed with the Secretary of State and then recorded in the public records of Palm Beach County, Florida. The amendment shall be considered effective when the Secretary of State considers the amendment filed."
