





ARTICLES OF INCORPORATION
OF
FLORIDA ART EDUCATION ASSOCIATION, INCORPORATED
A corporation not for profit

The undersigned subscribers to these Articles of Incorporation hereby make, describe, acknowledge and file these Articles for the formation of a corporation, not for profit, in the State of Florida.

ARTICLE ONE

The name of this corporation shall be FLORIDA ART EDUCATION ASSOCIATION, INCORPORATED, a corporation not for profit.

ARTICLE TWO

This corporation is formed for the purpose of promoting the study of the problems of teaching art in Florida; to encourage research and experimentation; to hold public discussions and programs; to publish articles, reports and surveys; to integrate the efforts of others with similar purposes; provided that, since it is the purpose of the corporation to be a non-profit corporation, educational organization, it shall only engage in activities consistent with its status as defined in Section 501 (c) (3) of the Internal Revenue Code of 1954 or any successor provisions thereto.

ARTICLE THREE

Membership shall be limited to individuals

professionally engaged in activities concerned with, or related to art, art education. Memberships are classified as follows:

A. Active Membership-Individuals in the State of Florida actively engaged in the teaching or directing of programs of art education, or in pursuits closely related to the field, are eligible for active membership.

B. Associate Membership-Individuals interested in or engaged in activities related to art or art education, or those preparing to teach art or art education. The associate membership shall carry all the privileges of an active membership except that of holding office.

C. Honorary Membership-Honorary Membership may be conferred upon retired Florida Art educators by vote of the association, upon recommendation of an active member and approval by the Executive Council. Honorary members shall have all membership privileges except that of paying dues.

D. Institutional Membership-Schools or any group interested in art education. One person is to be designated as representative with all membership privileges except holding elective office.

ARTICLE FOUR

This corporation shall have perpetual existence, and the existence shall commence on the date this is filed with the Secretary of State.

ARTICLE FIVE

The names and post office addresses of the subscribers to these Articles of Incorporation are:

D. Executive Committee - The Executive Committee shall be composed of the President, Past President, President-Elect, Recording Secretary, Treasurer, and the State Art Consultant, as an ex-officio member.

E. Fiscal Year and Administrative Period - The fiscal year of the corporation shall be from July 1, through June 30. The administrative year shall coincide with the fiscal year. Newly elected officers shall take office on the first of the fiscal year, following their election.

F. Control - All business transacted by the Board of Directors and the Executive Committee shall be presented for approval at the next regular business meeting of the corporation.

ARTICLE SEVEN

The number of Directors the corporation shall have shall be three (3), and the Directors and their addresses are as follows:

The aforesaid Directors shall serve as the initial Board of Directors until the first scheduled election following the issuance of these Articles of Incorporation.

ARTICLE EIGHT

The affairs of this Corporation will be managed

initially by the subscribing members who are the initial Board of Directors as set out above until the first regularly scheduled election, subsequent to the approval of the Articles of Incorporation, and thereafter is to be managed by the Board of Directors as set out in Article Six, Section B, and the Executive Committee as set out in Article Six, Section D, and all affairs managed by them shall be presented for approval at the next regularly scheduled business meeting of the Florida Art Education Association, Incorporated.

ARTICLE NINE

The By-Laws of this corporation may be amended by a majority vote of the voting members, provided that a proposed Amendment shall have been submitted in writing thirty (30) days in advance to the Board of Directors. If deemed necessary by the Board, the vote on the proposed Amendment, by the general membership may be conducted by mail ballot.

ARTICLE TEN

Amendments to the Articles of Incorporation may be proposed and adopted after presentation of the proposal to the membership, and upon the majority approval of the current active voting membership.

ARTICLE ELEVEN

The initial post office address of the principal office of this corporation in the State of Florida is 809A Blackstone Building, 233 East Bay Street, Jacksonville, Florida, 32202. The Board of Directors may, from time to

time, move the principal office to any other address in Florida.

ARTICLE TWELVE

Upon dissolution, all the assets of the Association shall be turned over to the National Art Education Association of the National Education Association of the United States, provided it is then exempt from Federal Income Taxes as a charitable and/or educational organization, or otherwise to such non-profit tax-exempt charitable, scientific or educational organization as the final Board of Directors of the Association shall select.
