

AMENDMENTS TO THE ARTICLES OF INCORPORATION

For Optimist Club of Gulf Breeze, Florida, Inc.

FIRST: Amendment adopted: Article III of the Articles of Incorporation is hereby amended to read as follows:

"The purpose of this organization shall be exclusively for charitable and educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code (or corresponding portions of any United States Internal Revenue Code), including, to the extent permitted by said section 501 (c)(3), the promotion and support of cultural, social and educational advancements for residents of Santa Rosa and Escambia Counties, Florida.

No substantial part of the activities of the Corporation shall be carrying on of propaganda or otherwise attempting to influence legislation and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

This Corporation is and shall remain a not-for-profit organization. The Corporation shall not have nor issue shares of stock. No dividends shall be paid, and no part of the net earnings of the Corporation shall inure to the benefit of its members, directors, or officers, or the benefit of any private individual."

SECOND: Amendment adopted: Article IX of the Articles of Incorporation is hereby amended to read as follows:

"The street address of the of the Corporation's registered office is: 1110 Gulf Breeze Parkway, Gulf Breeze, FL, 32561 and the name of the registered agent of this Corporation at that address is Clara Gray.

THIRD: Amendment Adopted: Article X of the Articles of Incorporation is hereby added and reads as follows:

DISSOLUTION

"In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501 (c)(3) of the Internal Revenue Code of 1954, or corresponding sections of any prior or future Internal Revenue Code, or of the State, Federal or Local government for exclusive public purpose."

FOURTH: Adoption of Amendment:

The amendments were adopted by the board of directors without shareholder action and shareholder action was not required.
