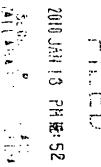

Article IV shall be amended as follows:
Membership may be obtained by an individual born into or converted to the Jewish faith, and the individual's spouse, commit
committed partner, or legal guardian of any children under age 25, who is of good moral character and who agrees to pay the
required dues, fees, tuition and charges as determined from time to time by the Board of Directors. Applications for
membership shall be in writing signed by the applicant or applicants and must be accompanied by a pledge of monetary
contribution, the amount thereof to be established from time to time by the Board of Directors. Membership of such
applicant or applicants shall become effective upon a majority vote of a quorum of the Board of Directors. The class or
classes of membership shall be established by a majority vote of a quorum of the Board of Directors, and shall be as described
fully in the By-Laws of the corporation.
The amendment was adopted by a majority of a quorum of the Board of Directors on the 21st day of May, 2017, and by a
two-thirds (2/3) majority of the members of the corporation present at a properly noticed meeting held on the 21st day of
May, 2017.
