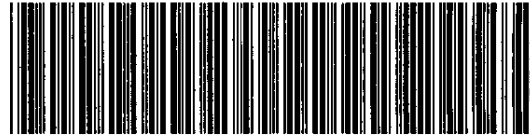

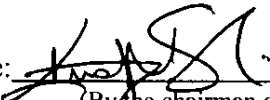

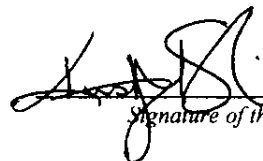

**PLAN OF DISTRIBUTION OF ASSETS OF

Pursuant to Section 617.1406, Florida Statutes, on February 25, 2014, the Board of Directors of The Gold-Diggers, Inc., and thereafter the general members entitled to vote, overwhelmingly passed a motion to file Articles of Dissolution of the corporation no later than the last day of the current fiscal year ending on June 30, 2014. The payment of all liabilities and the distribution of all assets were completed by June 25, 2014, as follows:

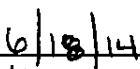
**Plan of Distribution of Assets**

- (1) All liabilities and obligations of the corporation were paid and discharged.
- (2) No assets were held by the corporation upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution.
- (3) All assets held by the corporation subject to limitations permitting their use only for charitable, benevolent or similar purposes, were transferred or conveyed to domestic societies or organizations engaged in activities substantially similar to those of the dissolving corporation, and on behalf of which the dissolving corporation annually raised and donated funds, to wit:  
The Leukemia & Lymphoma Society, Southern Florida and Puerto Rico chapter; and the Food for Life Network.
- (4) All other assets, being remaining membership funds, were also distributed to the afore-mentioned charitable organizations.
- (5) Consummation of this Plan of Distribution of Assets is authenticated by the President of the corporation in compliance with the requirements of Florida Statutes cited above, and are filed with the Articles of Dissolution.
