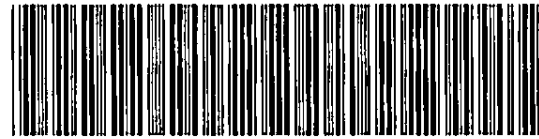

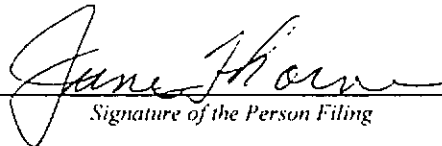

## **ABUNDANT LIFE CHURCH RESOLUTION FOR DISSOLUTION**

A special meeting of the Board of Directors was called by President June Thorne for July 25, 2017 6:00 p.m. A series of meetings had been initiated and conducted between the Board members. This special meeting was called to address the status and future of Abundant Life Church.

**WHEREAS; ABUNDANT LIFE CHURCH** was founded by L.M. Thorne, who served as Pastor from 1976 until 2014; and

**WHEREAS;** upon the death of Pastor Thorne, his son Larry Michael Thorne, took over as Pastor of the church and served until November 2014; and

**WHEREAS;** June Thorne, the widow of Pastor Thorne and mother of Larry Michael Thorne has served as a member of the Board of Directors of Abundant Life Church since 2004; and

**WHEREAS;** there is currently not a person serving in a permanent Pastoral position for Abundant Life Church; and

**WHEREAS;** attendance, membership, tithing and giving has all decreased since the passing of Pastor Thorne; and

**WHEREAS;** the legal and final affairs of Abundance Life Church of Fort Walton Beach, FL shall be overseen and directed by the Board of Trustees/ Directors; and

**WHEREAS;** this Board of Directors is charged with taking all steps necessary in the best interest of Abundant Life Church;

**BE IT RESOLVED** as follows:

1. The Board of Directors convened this special meeting on or about July 25, 2017 and all current members of the Board of Directors were present;
2. By a unanimous vote, as evidenced by the undersigned, the Board of Directors voted to cease operations as Abundant Life Church and to convey the real property, assets, furnishings and related equipment to the Destiny Worship Center, subject to the outstanding note and loan obligations now held by Bancorp South.
3. The conveyance of the property, buildings, equipment, and all furnishings of Abundant Life Church is expected to be scheduled for closing in the next 30 to 45 days, or as soon as possible;
