NOTICE OF MOTION FOR ENTRY OF FINAL DECREE AND ORDER CLOSING CASE

PLEASE TAKE NOTICE that, on February 8, 2006, the above-captioned reorganized debtors (the "Reorganized Debtors") filed their Final Report, Final Account and Motion for Entry of Final Decree and Order Closing Case (the "Motion"), by which the Reorganized Debtors seek entry of a final decree and order closing the Reorganized Debtors' sole remaining bankruptcy case, Case No. 03-32094 (DOT). The Motion may be examined on-line by interested parties at <http://administar.net/Ntelos/>.

Your rights may be affected. You should read these papers carefully and discuss them with your attorney, if you have one in this bankruptcy case. (If you do not have an attorney, you may wish to consult one.)

Under Local Bankruptcy Rule 9013-1, unless a written response to the Motion and supporting memorandum are filed with the Clerk of Court and served on the moving party not later than **March 1, 2006**, the Court may deem any opposition waived, treat the Motion as conceded, and issue an order granting the relief requested without further notice and hearing. If you do not want the Court to grant the relief requested in the Motion or if you want the Court to consider your view on the Motion, then on or before **March 1, 2006**, you or your attorney must: (1) file with the Court a written response, explaining your position, at U.S. Bankruptcy Court, 1100 East Main Street, Suite 310, Richmond, Virginia 23219; (2) mail a copy of your written response to counsel to the Reorganized Debtors at the addresses appearing below; and (3) attend the hearing scheduled to be held on March 8, 2006, at 11:00 a.m., in the United States Bankruptcy Court, United States Courthouse Annex, 1100 East Main Street, Room 335, Richmond, Virginia 23219. If you mail your written response to the Court for filing, you must mail it early enough so that the Court will receive it on or before the date stated above. If you or your attorney for not take these steps, the Court may decide that you do not oppose the relief sought in the Motion and may enter an order granting the relief.
