

AMENDMENT TO THE ARTICLES OF INCORPORATION

to the VICTORIOUS CHURCH OF GOD IN CHRIST, INC

We, the members, of the Board of Directors of Church Of God In Christ of Lumberton Inc, is vested with the management of the business and affairs of this Corporation, subject to the law, the Articles of Incorporation and the By-Laws.

August 16, 2001, it was voted and agreed upon by all members of the Board of Directors.

Pursuant to the Provisions of the undersigned Corporation adopts the following Articles of Incorporation:

ADMEND

Article II Purposes

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by and organization exempt from Federal income tax under section 501© (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon the dissolution of the corporation, assets shall be distributed to one or more exempt purposes within the meaning of section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall to distributed to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the court of Common Pleas of the county in which the principal office of the incorporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determined, which are organized and operated exclusively for such purposes.
