Earlier today we were notified by our legal Counsel that an "articles of dissolution" had been filed on behalf of Quail Ridge Country Club Inc effective August 16th, 2019. This was either filed inadvertently or there was an administrative clerical error made. Quail Ridge Country Club Inc. is an ongoing concern and should be immediately reinstated retroactively to the erroneous dissolution date.


