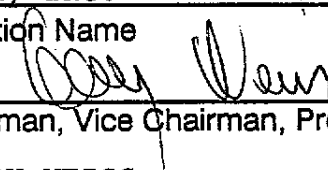

The name of the corporation shall be:

(the "Association").

II.

The purpose and objects of the Association shall be to administer the operation and
management of ~~THE HAMMOCKS~~ COURTSIDE AT BOCA WEST, a condominium (the
"Condominium"), to be established as a condominium in accordance with the Florida
Condominium Act (the "Act") upon land situated in Palm Beach County, Florida, described
as:

ALL OF THE HAMMOCKS OF BOCA WEST P.U.D. according to the Plat thereof
as recorded in Plat Book 32 at Pages 44 and 45 of the Public Records of Palm
Beach County, Florida.

and to perform the acts and duties incident to operation and management of the
Condominium in accordance with the provisions of these Articles of Incorporation, the By-
Laws of the Association which will be adopted (the "By-Laws"), and the Declaration of
Condominium of the Condominium (the "Declaration"), which will be recorded in the Public
Records of Palm Beach County, Florida, when the Land, and the improvements now and to
be constructed thereon, are submitted to the condominium form of ownership, and to own,
operate, encumber, lease, manage, sell, convey, exchange, and otherwise deal with the
Land, the improvements and such other property, real and or personal, as may be or become
part of the Condominium (the "Condominium Property") to the extent necessary or
convenient in the administration of the Condominium. The Association shall be conducted
as a non-profit organization for the benefit of its members.
