### Amendment to Article X of the Articles of Incorporation of Village of Cedarwood Association, Inc.

(new text underlined, deleted text overstricken)

#### AMENDMENT TO ARTICLES OF INCORPORATION

These Articles of Incorporation may be altered, amended or repealed by <u>a</u> resolution approved by a majority of the Board of Directors <u>present</u> at a duly constituted meeting of the Board of Directors in addition to the vote or written approval of Owners holding not less than a majority of the voting interests of the membership. No amendment affecting Developer shall be effective without the prior written consent of Developer. The prohibition against selling or mortgaging shall not be amended or deleted without the prior written consent of Developer.

Article X of the Articles of Incorporation of Village of Cedarwood Association, Inc. provides that the Articles of Incorporation may be altered, amended or repealed by resolution of the Board of Directors. The Articles do not require a vote of the members, so there are no members entitled to vote on the proposed amendment.
