#### RESTATED ARTICLES OF INCORPORATION OF AMENDMENT TO OUT-OF-DOOR ACADEMY OF SARASOTA, INC.

Pursuant to Sections 617.1002 of the Florida Corporations Not For Profit Act, Chapter 617, Florida Statutes, the Restated Articles of Incorporation of Out-of-Door Academy of Sarasota, Inc., a Florida corporation (the "Corporation"), not for profit, duly organized to do business under the laws of the State of Florida, the current Restated Articles of Incorporation of which were filed with the Department of State of the State of Florida on November 16, 1998, are hereby amended as follows:

### ARTICLE IV

#### BOARD OF TRUSTEES

There shall be a Board of Trustees composed of not less than twelve (12) nor more than twenty-four (24) members, as established by the Bylaws.

#### <u>ARTICLE IX</u>

#### AMENDMENT OF ARTICLES OF INCORPORATION

Section 2 of Article IX shall be amended to permit notice of any proposed amendment to the Articles of Incorporation to be sent via regular U.S. Mail, postage prepaid, to each Member's address of record held by the corporation, by e-mail to the Member's email address on record with the corporation, or by hand-delivery.

This amendment to the Restated Articles of Incorporation of the corporation (i) has been duly authorized and approved by the requisite vote of the members of the corporation as required under and pursuant to Chapter 617, Florida Statutes, and (ii) supersedes and replaces Article IV and supplements Article IX of the 1998 Restated Articles of Incorporation of the corporation.
