3. ARTICLE IX - BYLAWS is deleted and the following substituted therefor:

> The Bylaws of the Corporation are to be made and adopted by, and may be altered, amended or rescinded by, the Members of the Corporation, although they may be recommended by the Board of Directors of the Corporation. Bylaws shall not conflict with these Articles of Incorporation.

4. ARTICLE X - AMENDMENTS TO ARTICLES is deleted and the following substituted therefor:

Any Member, Director or Officer of the Corporation may propose that these Articles of Incorporation be amended, but these Articles of Incorporation may be amended only by the act of a majority of the Members of the Corporation, subject to the approval of the Presbytery of Tampa Bay.

5. Except as modified herein, the Articles of Incorporation remain in full force and effect.
