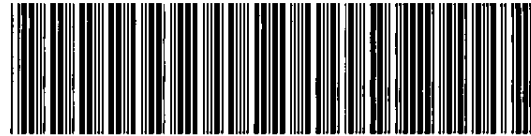

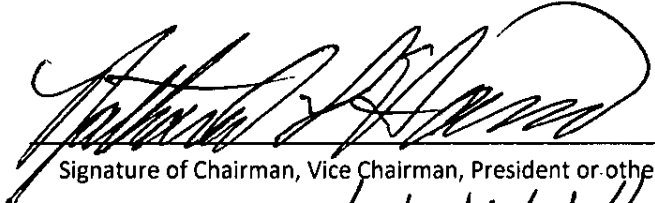

ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

Mount Zion Northeast Coast Missionary Baptist District Association of Florida, Incorporated

A Corporation Not for Profit Incorporated Under the Laws of Florida

We , the undersigned hereby amend the following Articles:

Article II (Amended bold section)

The general purpose and object of this Corporation shall be to promote and support district, state, home and foreign missions; Christian Education; Evangelism and Benevolence.

Said organization is organized exclusively for charitable, religious, educational, & scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal code.

Article IV (Amended bold section)

All revenue, profit, income and money received from the conduct of such business or enterprise is to be Used and employed in religious, educational , charitable, benevolent, and missionary work and ? for the ? of the members of said Corporation either as individuals or collectively.

No part of the net earnings of the organization shall inure to the benefit of , or be distributable to its members, trustee, officers, or other private persons, except that the organization shall be authorized , and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization , contributions, to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article XX (Added bold section)

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization(s), as said Court shall determine, which organized and operated exclusively for such purposes.
