Amendment Adopted:

ARTICLE XVI - Relationship to National Organization

Section 1: Central Florida Chapter, Paralyzed Veterans of America, recognizes the National Organization, known as the Paralyzed Veterans of America, chartered by the U.S. Congress, and affirms its allegiance as a subsidiary of the National Organization, its Charter, Bylaws and all rules, mandates and regulations promulgated thereto.

Section 2: <u>Central Florida Chapter</u>, <u>Paralyzed Veterans of America</u>, shall perform the duties and obligations set forth in the Paralyzed Veterans of America Bylaws, Administrative Guide and Chapter Administrative Manual or other such duties and obligations as the PVA Executive Committee or Board of Directors may, from time to time, require.

Section 3: <u>Central Florida Chapter, Paralyzed Veterans of America</u>, shall not amend its Articles of Incorporations unless it receives prior written approval of the PVA Executive Committee.

Section 4: <u>Central Florida Chapter</u>, <u>Paralyzed Veterans of America</u>, shall dissolve whenever the corporation's Charter is surrendered to or revoked by the Paralyzed Veterans of America.

Section 5: In the event of dissolution of <u>Central Florida Chapter</u>, <u>Paralyzed Veterans of America</u>, for any reason, any assets and property remaining after compliance with applicable provisions of state law shall be distributed to the Paralyzed Veterans of America.

The date of adoption of the amendment was: November 8, 2006.
