

RESTATED ARTICLES OF INCORPORATION

<u>OF</u>

FLORIDA EDUCATION ASSOCIATION HOLDING CORPORATION, INC.

(Charter No. 739350)

In accordance with the provisions of Section 617.1007, Florida Statutes (2001), the Board of Directors of the above corporation adopts these Restated Articles of Incorporation.

The Articles of Incorporation are restated as follows:

ARTICLE I

Name and Principal Place of Business

The name of this corporation shall be the "Florida Education Association Holding Corporation, Inc." The principal place of business is: 213 South Adams Street, Tallahassee, Florida 32301.

<u>ARTICLE II</u>

Purpose

The purpose of this corporation is to hold legal title to real property for the use and benefit of the Florida Education Association which shall hold equitable title thereto.

ARTICLE III

Members

The members of this corporation shall consist of those persons who serve as officers and directors of the corporation.

ARTICLE IV

Term

This corporation shall have perpetual existence.

ARTICLE V

<u>Officers</u>

The corporation shall have three officers as follows: President, Vice-President, Secretary/Treasurer. The office of President will be held by the person who serves as President of the Florida Education Association. The office of Vice-President shall be held by the person who serves as Vice-President of the Florida Education Association. The office of Secretary/Treasurer shall be held by the person who serves as Secretary/Treasurer of the Florida Education Association.

<u>ARTICLE VI</u>

Board of Directors

There shall be a Board of Directors for this corporation, which shall consist of not less than three members. The Board of Directors shall consist of those persons who serve as Officers of the Florida Education Association and the Chief of Staff of the Florida Education Association.

ARTICLE VII

By-laws

The Board of Directors shall have the power, but not the duty, to adopt by-laws of this corporation, to alter, amend or repeal such by-laws or to adopt new by-laws.

<u>ARTICLE VIII</u>

Amendments

These Articles of Incorporation may be amended in the manner provided by law upon approval of the Board of Directors.

ARTICLE IX Dissolution

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such a manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall, at the time, qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or to a labor organization or organizations which shall, at the time, qualify as an exempt organization or organizations under Section 501(c)(5) of the Internal Revenue Code of 1954, as amended, as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by an appropriate court of jurisdiction where the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated for such purposes.

Registered Office

In accordance with the provisions of Sections 617.0501, 617.0502 and 617.0503, Florida Statutes (2000), the registered office of the corporation shall be located at 2544 Blairstone Pines Drive, Tallahassee, Florida 32301, and the Registered Agent shall be Ronald G. Meyer, Esquire.
