ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF SUNNYSIDE BEACH AND TENNIS CLUB CONDOMINIUM ASSOCIATION, INC., A FLORIDA CORPORATION

Pursuant to the provisions of Section 617.1006 of the Florida Not-for-Profit Corporation Act ("Act"), the following amendment to the Articles of Incorporation of SUNNYSIDE BEACH AND TENNIS CLUB CONDOMINIUM ASSOCIATION, INC., a Florida corporation ("Corporation") was adopted by the members of the Corporation on the 2011 day of October, 2002, in the manner prescribed by the Act:
