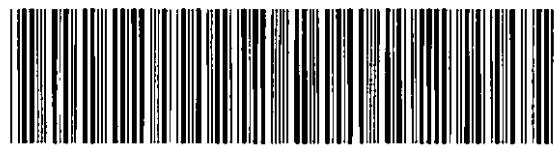

ARTICLES OF INCORPORATION

OF

RIDGEWOOD AVENUE FIRST CHURCH OF GOD, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporations not for profit under the following proposed Charter:

ARTICLE I  
NAME

The name of the corporation shall be RIDGEWOOD AVENUE FIRST CHURCH OF GOD, INC. and is to be located in Volusia County, Florida.

ARTICLE II  
OBJECT

The general nature of the object of the corporation shall be that the members desire for themselves, their associates and successors, to be incorporated and made a body politic as a church, instituted under the name and style of RIDGEWOOD AVENUE FIRST CHURCH OF GOD, INC. To care for the secular, temporal, financial and legal affairs of RIDGEWOOD AVENUE FIRST CHURCH OF GOD, INC. and recognize that the WORD OF GOD is the only divine standard of faith and practice and the final authority on all matters of life and conduct.

ARTICLE III  
MEMBERSHIP

The membership shall be open to all persons sixteen (16) years of age or older who have worshipped regularly with this Church for at least three (3) months and supported the work to the best of their ability. They must have lived a Christian life during that period in harmony with the accepted standards and doctrines of the Church.

ARTICLE IV  
TERM

This Corporation shall have perpetual existence.

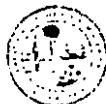

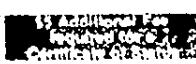
